- 3. Tree Canopy & Town Ordinances
  - a. Jamie Groce spoke about updated tree ordinances.
  - b. Overhead LIDAR information will be gathered but the city would need to hire someone to translate that info into tree canopy numbers.
    - i. Grants may be available for interpretation of this data.
  - c. Changes made in 2021:
    - i. Minimum planting formulas, hopefully discourages clear cut so they don't have to go back and plant as many trees.
    - ii. Checklist now exists for demonstrating agricultural property use.
  - d. Town typically issues 170 permits for new homes per year, down to ~80 this year.
  - e. Developers hire surveyors to count trees then submit the plans to the city, the requirements for tree keeping/planting back are determined based on that.
    - i. Once we have a tree canopy number perhaps the ordinance could be changed to include the impact the development would have on the existing number.

- f. Does the town do anything regarding invasive species? sometimes they ask businesses to remove them but that doesn't always work.
- g. How big is the tree bank and they are open to suggestions on where to spend it? It's usually ad hoc as to how the money is spent, when a project comes up if it needs trees and it could ease the city budget, they use it. Jamie will get back to us regarding how much is in the bank, and they are open to suggestions.
